Important Facts:

1. Coaches must sign off on an acceptable Sports Engine roster before competing in any matches on the day of the event.
2. Teams that have not turned in their Sports Engine roster for their team will not be eligible to participate. (NO EXCEPTION!) **Please present your roster at the tournament table upon arrival to the facility.** No teams will be able to participate until the Sports Engine roster has been signed by the coach or other staff personnel listed on the roster. Thank you.
3. There will not be a coaches meeting, any changes will be provided to you when checking in that morning and signing the acceptable Sports Engine roster.
4. **No food may be brought into the facility. Any coolers must be kept in the car.**
5. Concessions will be provided by the facility. **We have healthy options available at the concession stand**
6. **Gym bags should be placed in the assigned spectator area in bleachers of your playing gym.**
7. Neither Lakeside Lutheran High School nor the River City Volleyball is responsible for lost or stolen items.
8. Region up referees will be provided, if available.
9. Please start the warm-up time immediately following the conclusion of the previous match. First and second match of the day warm-up is 2-4-4, all matches after will be 3-3 with serving within your time.
10. Teams must provide a down official (R2), scorekeeper, libero tracker, & 2 lines judges.
11. Admission charge is \$5 per person.
12. There shall be no one in the school hallways warming up or "hanging out". The halls will be monitored.

Rules: USA Volleyball rules will be utilized. There will be a tournament directors table set up in the facility.

COVID: *-Everyone is expected to wear a mask at all times. Please socially distance whenever possible and maintain appropriate sanitation skills.*

-If you show signs or symptoms of COVID-19 or have been exposed to COVID-19 in the past 10 days, please STAY home.

-By entering the facility, you are acknowledging the possibility of coming into contact with someone carrying COVID-19 & with the understanding that Lakeside Lutheran and River City are not responsible for these possibilities.

****Athletes are allowed 2 spectators per person. Please enter with your athlete. \$5 per person**

-Each team will have an assigned bleacher area in their perspective gym.

Warm-Ups: Team warm-ups will consist of 2-4-4 prior to their first match of play (2 shared ball handling, then 4 of each team having their court time which includes serving). All subsequent matches will consist of 3-3 (each team will have to serve within the 3 minutes.). The first match of the day will start on time. All matches that follow may run ahead of schedule. It is the responsibility of each team to follow the progress on their next assigned court and be ready to play when the court is available.

Format: All teams are guaranteed 4 matches. There will be 2 pools of 4 teams. Matches will consist of best of 3. The first two games rally scored to 25 points and the third if necessary rally scored to 15 points. The top 2 teams in each pool go to the Gold Bracket and bottom 2 teams go to the Silver Bracket. The event is scheduled to conclude by or near 5:00 pm. Refing assignments are listed in the schedule, please be mindful of the structure.

Tie Breakers: There will not be any tie breakers. Pool results will be based on the following criteria: Head to head, GAME WINNING % (Games won divided by games played), then TOTAL POINT DIFFERENTIAL (Total # of points won subtracted from total # of points lost), then COIN FLIP.
